I wish to thank everyone in the 4-H community for their assistance over the past 24+ years. With that said, I am announcing my retirement from Kenosha County UW-Extension on April 24<sup>th</sup>.

I began working with Kenosha County on April 24, 1989, as a clerk in Family Court. On December 3, 1991, I transferred to UW-Extension. It has been a great experience. Lorraine Phillips was the secretary for youth development and I worked with the other programs – Agriculture, Horticulture, CNRED and Family Living. Tedi Winnett became our director about the same time.

At that time, we printed the Home Lite on a mimeograph machine. Lorraine and I printed, stapled, collated, and mailed over 700 copies every month. Now, because of technology, we only mail out about 40 copies – the rest being done through 4-Honline.

I have enjoyed working with the 4-H community, the Master Gardeners and the HCE program. Things will undoubtedly change here in the UW-Extension Office, but you will continue to receive fantastic support. I feel Kenosha County has one of the best UW-Extension offices in the state. The support we receive from the Kenosha County Board and the other departments is phenomenal.

As a youth, I, too was a 10 year 4-H member and able to learn a lot and experience much that 4-H has to offer. I exhibited sewing at the Wisconsin State Fair, attended the 4-H Youth Conference, and earned the Key Award. One of the best memories I had was attending Citizenship Washington Focus in 1969. The trip left a permanent mark in my heart. I heard ghosts at Gettysburg Battlefield, toured the White House, and visited Kennedy's grave at Arlington Cemetery. I encourage all of you to do your best and experience all that 4-H is!



Happy Spring Horse project members, there is a lot to do in the next few months so try to attend as many meetings and clinics as possible and check your email often for project opportunities (remember that some of these clinics will only be offered this year as our budget allows, so please take advantage of them).

If you are planning on getting shots on APRIL 4 OR APRIL 11 PLEASE LET MICHELLE COX KNOW SO WE CAN INFORM BRISTOL VET!!! ASAP!!!! This opportunity is for Kenosha County Horse Project members only. All horses participating at Kenosha County Fair and Wisconsin State Expo (in September) must have had the Coggins pulled and proper shots for their horses. Shots required are Tetanus, East and West, West Nile, Rhino and Flu. The Rhino and Flu must be within two weeks of Fair.

The Round Robin is a little different. You are invited to bring your horse to the old clinic in Union Grove on Hwy 142. The dates are April 4th or April 11th from 8am to noon. Vaccinations are 25% discounted. Do not contact the Vet to let them know you are coming. We will provide them a list of those bringing their horses. Each member may bring 2 horses, up to 4 per family.

This spring starts with a bang at the Midwest Horse Fair, come and check out the new facilities April 17, 18 & 19th at the Alliant Energy Center.

Please review your attendance at <a href="http://kenosha.uwex.edu/youth-development/4-h/horse-program">http://kenosha.uwex.edu/youth-development/4-h/horse-program</a>. As a reminder, each member is required to attend a minimum of two county-wide meetings, and a minimum of two clinics/ workouts. The fifth meeting requirement can be a meeting or a clinic/workout - to be eligible for Kenosha County Fair, State competitions and Champion Challenge. Requirements are to be met by August 2, 2015. All members must sign in at all meetings, workouts, clinics, and mini-camp. (Horse shows and Pre Fair do not count.)

Countywide meetings are held on the third Wednesday each month Sept - May (excluding Dec). The next countywide meeting will be on April 15th, (at Central High School) and the next Horse Project Board meeting will be held on April 13th (at the Kenosha County Center - open to all members).

Scheduled dates for clinics are:

- Gymkhana May 16th 10am-2pm Colleen's Farm and
- June 6 9am 1pm at the Clinics/Workouts for Gymkhana is opened to all members, but Horseless Horse members may only audit.
- Gymkhana workout dates are May 4, 19; June 1, 16, 29; July 14, 27; August 4 at Colleen's Barn
- Pleasure workouts are open to all riders. You may either ride or audit. Scheduled dates will provided soon.

All members attending Mini Camp, Clinics, and/or work-outs with a horse must provide the horse's Coggins. Without your Coggins, the horse will not be allowed on premise. All members must wear long pants, boots with a heel and SEI helmet. No exceptions.

If you are planning on keeping your horse at the Fairgrounds during the Kenosha County Fair please complete the forms required they are available on the horse project web site. All members in good standing at the time of the fair are invited to keep their horse(s) at the barns. Stalls will be assigned on a first-come first-served basis. There will be a meeting in August including cleaning the barns that all members will be asked to attend if they are planning to keep their horse at the Fair. In addition, all members keeping their horse at the fairgrounds will be required to sign up for barn duty. Lauren Brylinke is the coordinator.

The Tractor Certification Course is a 24-hour program designed to teach safety as it relates to driving farm implements on **public roads**, offering both classroom and hands-on tractor driving experiences, for youth under the age of 16 and over the age of 12.

This course meets the Wisconsin Act 455, Section 10, Section 346.925 "Operation of agricultural machinery by youthful operators" law that states:

"...After April 30, 1996, no person may direct or permit a child under the age of 16 years to operate a farm tractor or self-propelled implement of husbandry on the highway unless the child has been certified as successfully completing a tractor and machinery operation safety-training course..."




## Scholarship Application Due!

## 2015 Wisconsin State Fair Junior Market Barrow Identification Information

Youth interested in showing Junior Show market beef, sheep or swine at the 2015 Wisconsin State Fair will need to get their animal projects DNA/RFID identified through

the Wisconsin Livestock Identification Consortium (WLIC) by the respective State Fair eligibility deadlines. WLIC is coordinating a statewide DNA/RFID identification program for Wisconsin County and State Fairs. This identification system allows animals which are DNA/RFID identified through the WLIC County and State Fair program to meet Wisconsin State Fair Identification requirements as long as the process is completed (all forms returned and samples on file) by the respective Wisconsin State Fair identification deadline postmark.

Beef: Monday - February 9, 2015
Sheep: Monday - May 11, 2015
Swine: Monday - May 11, 2015

**How do I get my animals identified?:** Request DNA/RFID tag identification by going to the WLIC website at <a href="www.wiid.org">www.wiid.org</a>. Click on the button "County Fair DNA/ID project" (right side). Print out, complete and mail the request form with payment to WLIC. Make sure you return DNA and required paperwork to WLIC by the Wisconsin State Fair identification postmark deadline listed above. Tags and paperwork are ONLY available through WLIC. The Wisconsin State Fair Office no longer processes DNA/RFID tag requests.

**How much will DNA/RFID identification cost?:** \$10 per animal identified for required DNA and RFID tag identification. If your animal has an existing 840 RFID ear tag you can purchase and submit a DNA envelope separately for \$5.00. Be sure to list the existing RFID ear tag number on the paperwork and DNA submission.

Will my County DNA/RFID tag qualify for Wisconsin State Fair?: Wisconsin State Fair will accept all DNA/RFID samples submitted through WLIC by the respective Wisconsin State Fair identification postmark deadline. Samples for Wisconsin State Fair postmarked after the Wisconsin State Fair identification deadline postmark will NOT be accepted. Please check the WLIC website (www.wiid.org) to verify which counties are participating in the statewide DNA/RFID identification program.

What if my County is not participating in the statewide DNA/RFID program? No problem! Request Wisconsin State Fair DNA/RFID identification through WLIC. Make sure you return DNA and required paperwork to WLIC by the Wisconsin State Fair identification deadline postmark listed above.

**Do I need to let Wisconsin State Fair know I have my animal DNA/RFID identified?** No required DNA/RFID identification paperwork needs to be sent to Wisconsin State Fair. Wisconsin State Fair will receive eligible market animal identification numbers from WLIC after the Wisconsin State Fair DNA/RFID identification postmark deadline. Potential exhibitors are required to submit their Fair entries prior to the June (online or paper) entry deadlines by entering directly with Wisconsin State Fair. DNA/RFID identification is NOT your entry to the Fair.



**Do I need to have my Open Show Barrows DNA/RFID identified?** No. Barrows being shown in the Wisconsin State Fair Open Swine Barrow Show do NOT need to be DNA/RFID identified.
