POSITION DESCRIPTIONS

➤ **Youth Director:**

The Kenosha County 4-H Summer Camp Youth Director assists in planning, implementing and evaluating the entire camp experience. Specific duties include leading camp planning meeting(s), facilitating campfire programs, coordinating camp awards and providing support to the entire camp program.

➤ **Youth Counselor:**

The Kenosha County 4-H Summer Camp Youth Counselors have direct responsibility for assigned campers. Specific duties include teaching & leading games, songs, and other activities. In addition, the Youth Counselors are responsible for providing a safe environment for campers.

➤ **Chaperones:**

Each Kenosha County 4-H Summer Camp Chaperones position have unique responsibilities based on camp program needs. The responsibilities may include: Camp Nurse, Recreation Leader, Camp Fire Coordinator and Craft Leader.
