Farm Ready Research Webinar Series



Kenosha County Land and Water Conservation

The Kenosha County Land and Water Conservation office works with landowners and farm operators to develop and implement conservation practices for agricultural lands to protect and improve soil health and water quality. Some practices may be eligible for cost-sharing, often up to 70%, through the Kenosha County Soil and Water Resource Management Program. In addition, help is available for producers to learn how to write their own nutrient management plans using Wisconsin's SnapPlus software.

To find out what conservation practices may be a good fit for your land or to learn more about nutrient management planning using SnapPlus, contact Mark Jenks, County Conservationist, in the Kenosha County Land and Water Conservation office at 262-857-1900. If you would prefer to meet in-person, either in the office or on your farm, please call ahead and schedule an appointment. The Land and Water Conservation office is in the Kenosha County Division of Planning and Development in the Kenosha County Center located at 19600 75th Street, Bristol, WI. Office hours are 8-12 and 1-5pm, Monday through Friday.

Flood Maps, Flood Insurance and Your Property

Kenosha County is one of almost 600 communities in Wisconsin to participate in the National Flood Insurance Program (NFIP). As part of that program and in partnership with local governments, the Federal Emergency Management Agency (FEMA) works with communities to identify flood hazards and promote ways to reduce the impact of those and other hazards. Flood maps are used for floodplain management, flood insurance rating, and to determine flood insurance requirements.

Did you know?

If you live in an area with low or moderate flood risk, you are 5 times more likely to experience flood than a fire in your home over the next 30 years.

No matter where you live or work, some risk of flooding exists. To find your community's flood map, visit the online FEMA Flood Map Service Center, then type in your address and search. You may view, print and download flood maps, and view all products related to your community. If you would like help in finding the FEMA flood maps for your property, feel free to contact the Kenosha County Division of Planning and Development at 262-857-1900. Coronavirus Food Assistance Program

USDA announced up to an additional \$14 billion for agricultural producers who continue to face market disruptions and associated costs because of COVID-19. Signup for the Coronavirus Food Assistance Program (CFAP 2) will be September 21 through December 11, 2020.

USDA will use funds being made available from the Commodity Credit Corporation (CCC) Charter Act and CARES Act to support row crops, livestock, specialty crops, dairy, aquaculture and many additional commodities. CFAP 2 payments will be made for three categories of commodities – Price Trigger Commodities, Flat-rate Crops and Sales Commodities. To apply, contact the FSA office in Union Grove at 262-878-3353. Watershed Protection Committee of Racine County (WPCR)

The Watershed Protection Committee of Racine County (WPCR) consists of a team of local farmers who lead efforts in erosion control, water quality improvement, and providing information to farmers and rural landowners regarding the use of conservation practices. These practices include grassed buffers, cover crops and no till to promote soil health.

The WPCR cost-share program offers two incentives. An incentive payment of \$500 is available for entering into a grassed buffer program, such as CRP or CREP. A cover crop incentive pays \$25 per acre, with the farmer matching the acres with covers. Contact Chad Sampson at Racine County Land Conservation for more information.

The WPCR held a summer field day at Weis Farms in Burlington on September 10th. The field day featured a soil pit, cover crops, planting green, and a soil runoff simulator. The next winter workshop will be in early February, featuring farmer Rick Clark talking about his soil health journey.

USDA Offers Secure New Options for Signing and Sharing Documents Online

Producers working with FSA can now sign and share documents online in just a few clicks. By using Box or OneSpan, producers can digitally complete business transactions without leaving their homes. Both services are free, secure, and available for multiple FSA programs. FSA Encourages Farmers and Ranchers to Vote in County Committee Elections

The 2020 Farm Service Agency County Committee Elections begin on Nov. 2, 2020 when ballots are mailed to eligible voters. The deadline to return ballots to local FSA offices, or to be postmarked, is Dec. 7, 2020.

County committee members provide a link between the agricultural community and FSA. Farmers and ranchers elected to county committees help deliver FSA programs at the local level, applying their knowledge and judgment to make decisions on many different FSA programs.
