## Welcome

Welcome to Youth As Resources. You have become a part of a growing movement that is recognizing young people for their tremendous potential to positively influence the world around them.

Youth As Resources (YAR) is a grant giving organization that helps youth groups in Kenosha County to plan and implement meaningful community service and service-learning projects. By involving youth in their communities, YAR not only empowers young people to be active and engaged citizens, but it also strengthens the communities of Kenosha County.

By joining Youth As Resources, you are dedicating yourself to the goals and ideals of Youth As Resources. This manual is intended to help you understand how YAR works and to provide valuable board member resources throughout the year. Congratulations and thank you for making this commitment to yourself and your community!

## History

Youth As Resources began as a project of the National Crime Prevention Council in 1987 with funding from the Lily Endowment, Inc. Since 1987, Youth As Resources programs have formed all over the United States and even abroad.

In 2004, Kenosha County Youth As Resources was established as a partnership between Extension Kenosha County and the United Way of Kenosha County, in response to a 2002 Search Institute study citing that only 23% of youth perceived that “adults in the community value youth,” and only 26% felt that youth are “given useful roles in their community.”

Since that time, Kenosha County Youth As Resources has worked to combat these findings, and help youth feel that they can be valuable resources in their communities. As of September 2021, Kenosha County Youth As Resources has granted funds totaling \$79,230 to 215 youth-led service projects!

## Overview

The Youth As Resources Board of Directors (hereinafter referred to as the YAR Board) is a group of youth and adults that meet regularly to sustain the Youth As Resources program. The YAR Board is responsible for everything ranging from publicity and recruitment, to administration and outreach, and much more.

Central to the YAR Board's activities are awarding youth-led service grants to youth groups in Kenosha County and the development of valuable leadership skills.

To ensure that there is a balance between encouraging mentorship and promoting strong youth voice, Youth As Resources maintains a board that is made up of 9 youth (grades 9-12) and 3 adults. The goal is to recruit board members that reflect the demographics of the county population and have representation from a variety of schools throughout Kenosha County.

## Board Officers

Board officers have very specialized roles which ensure the successful operation of the YAR Board and all its projects. Board officers are elected to one-year terms and may run for multiple terms. A board member wishing to run for an office should read over the responsibilities of that position and be prepared to explain why they would be a good person for that position.

### President (Youth)

- ◆ Leads the board meetings.
- ◆ Helps to prepare the meeting agenda with the Vice President and the YAR Coordinator prior to the meetings.
- ◆ Sends meeting materials to YAR Board via email prior to the meetings with help of YAR Coordinator.
- ◆ Ensures that two service projects are carried out by the YAR Board each year.
- ◆ Represents Kenosha County Youth As Resources at various community events.

### Vice President (Youth or Adult)

- ◆ Assists the President.
- ◆ Fulfills the duties of the President if they are absent.
- ◆ Helps to prepare the meeting agenda with the President and the YAR coordinator prior to the meetings.
- ◆ Proposes potential community service projects for the YAR Board to implement in the fall and spring each year.
- ◆ Welcomes all groups requesting funds and establishes the order for the President.
- ◆ Represents Kenosha County Youth As Resources at various community events.



### **Secretary (Youth)**

- ◆ Records meeting minutes, attendance, and absences which are submitted to the Extension Office before the next meeting and are reviewed by the YAR Board.
- ◆ Recaps and sends important meeting topics discussed via email to YAR Board after meeting adjourns with help of YAR Coordinator.
- ◆ Coordinates correspondence with the media.
- ◆ Responsible for new board member recruitment.
- ◆ Represents Kenosha County Youth As Resources at various community events.

### **Treasurer (Youth)**

- ◆ Responsible for keeping accurate records of YAR funds available for a given year.
- ◆ Responsible for distributing voting dots at each YAR granting meeting.
- ◆ Responsible for all voting records and submitting official grant information to the Extension Office in a timely manner.
- ◆ Responsible for reviewing receipts and verifies monies spent from grant projects after project completion.

### **Parliamentarian (Adult)**

- ◆ Ensures Robert's Rules of Order are adhered to at all official meetings.
- ◆ Ensures bylaws of YAR are adhered to at all official meetings.

## **Endowment Committee**

### **Endowment Committee Members (Youth)**

- ◆ Two youth provide representation to the Youth As Resources (YAR) Endowment Committee.
- ◆ Responsible for reporting YAR Endowment Committee updates at the YAR Board meetings.



## **Board Meeting**

The Youth As Resources meetings are arranged in a way to create rituals and traditions within the organization. When these rituals and traditions are established, it builds an environment that is conducive to youth participation in an efficient manner.

After the project presentations are over, the board goes into a closed session. During that closed session, discussion about the presentations takes place, followed by voting. The voting process begins with the youngest board member first and then moves up to the adult board members. This ritual enhances youth participation and ownership.

### **Voting on Grant Presentations (Closed Session)**

- To ensure maximum youth voice in decision making, nominal group process voting procedures have been developed.
- Each board member is given an equal number of dots by the Treasurer. The dots represent \$10.00 each. The number of dots is determined by either the total amount of money requested or the total amount of funds available in the grant cycle.
- If a YAR Board member must abstain from voting on a project due to a conflict of interest, then their dots are distributed to remaining board members.
- Voting age is determined by age youngest to oldest.



## Sample Meeting Agenda

The following is an example agenda that is given out at the beginning of the YAR Board meeting.

YAR Board members are strongly encouraged to ask questions of each presenter. It is important to learn as much about each project before making a funding decision.

### **Call the Meeting to Order** **Pledge of Allegiance and YAR Pledge**

#### **Secretary Report**

- Review. Then, motion, second, discussion, and vote to accept the secretary's report, if there are no changes.

#### **Treasurer Report**

#### **Grant Presentations (open session)**

- The order of groups is determined by the Vice President.
- The introduction and dismissal of the groups is led by the President.
- The timing of the groups is conducted by the Treasurer.
  - 3 minutes for presentation.
  - 2 minutes for board questions (Turn to page 8 for sample questions).

#### **Grant Discussion (closed session)**

- Motion, second, discussion, and vote to move into closed session.
- The granting discussion is facilitated by the President.
- The President proceeds one group at a time asking for positive comments and then for areas for improvement.
- After all groups have been discussed, the President will move into voting phase.

#### **Voting on Grant Presentations**

- To ensure maximum youth voice in decision making, nominal group process voting procedures have been developed.
- Each board member is given an equal number of dots by the Treasurer. The dots represent \$10.00 each. The number of dots is determined by either the total amount of money requested or the total amount of funds available in the grant cycle.
- Each board member can distribute their dots between grant requests as they see fit. If a board member does not want to spend their full allotment of funds, they can bank some or all of their dots for future use.
- Voting age is determined by age youngest to oldest.



### **Approval of Funds**

- After the voting is completed, there needs to be a simple majority vote to approve the funds that are awarded to each group.
- Motion, second, any discussion, and vote for each group.

- Endowment Committee
- Membership Committee
- Outreach Committee
- Social Media Committee

### **Unfinished Business**

- Include any unfinished items from the previous meeting.

### **New Business**

- Include any new items of business.

### **Announcements**

- This is the time when general announcements can be made.

### **Adjournment**

- Motion, second, and vote to adjourn the meeting.





## President's Remarks for Granting Meetings

Everyone is now excused from the meeting as we will begin our deliberations regarding grant requests. You will receive a letter from Extension Kenosha County in about a week informing you of the results of your grant application. Have a great evening!

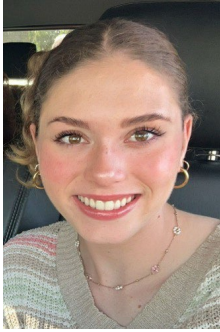

## Bylaws

### I. NAME

- A. This organization shall be known as Kenosha County Youth As Resources.

### II. PARTNERS

- A. Kenosha County Youth As Resources is a program of Extension Kenosha County.
- B. The fiscal agent of Kenosha County Youth As Resources is the United Way of Kenosha County.
- C. The Youth As Resources Endowment Committee provides oversight of the Youth As Resources Endowment Fund in collaboration with the Kenosha Community Foundation.

### III. MISSION

- A. Through grant-making, Kenosha County Youth As Resources empowers youth to design and implement projects that meet community needs.

### IV. BOARD MEMBERSHIP

- A. Youth As Resources does not discriminate against anyone for reasons of race, color, gender/sex, gender identity, creed, disability, religion, national origin, ancestry, age, sexual orientation, pregnancy, marital or parental status, arrest or conviction record, or veteran status.
- B. A background check is required of all adult members joining the YAR Board due to working alongside youth members.
- C. Board members of Youth As Resources cannot simultaneously serve as Youth in Governance appointees (in accordance with Youth in Governance bylaws).
- D. Board members of Youth As Resources:
  - i. Will be selected based on experience, interest, and commitment to the Youth As Resources philosophy and the Kenosha County community. Members will reflect the geographic, ethnic, professional, and economic diversity of the Kenosha County community.
  - ii. The Board will consist of no more than 12 persons, 9 youth and 3 adults.
  - iii. Youth members are defined as high school students. Adult members are classified as high school graduates who are 18 years of age and older.
  - iv. All members must demonstrate a strong desire to participate, an overall good attitude, high levels of reliability, strong attendance, and show a willingness to work.
  - v. Board members are required to attend at least one YAR service project per year (one in fall and one in spring).
  - vi. The YAR year will run from September through May.
  - vii. Board members will sign the Youth As Resources/United Way Conflict of Interest Policy annually.



## **V. ELECTION AND REMOVAL OF OFFICERS**

- A. Board officers will be elected in May, unless extenuating circumstances occur. In the case of elections not taking place in May, elections will be rescheduled at the discretion of the YAR Board.
- B. Board officers may be removed by a simple majority vote if the officer fails to fulfill the duties of their office.
- C. Vacancies during the year will be filled by Presidential appointment and simple majority vote of the YAR Board.

## **VI. MEETINGS AND ATTENDANCE**

- A. Official board meetings are held on the third Tuesday of the month from 5:00 pm – 7:00 pm at the United Way of Kenosha County/KABA Training Room (unless the meeting must be held virtually or an event prevents use of this room).
- B. A quorum is required for motions, official business, and voting. A quorum is defined as at least 50% of the current YAR Board. A majority vote with a quorum is necessary to pass motions and fund allotments.
- C. Members are expected to attend all board meetings. The Secretary will record attendance and unexcused absences. Members who have two unexcused absences will be removed at board discretion by majority vote.
  - i. An excused absence is recorded at least two business days in advance unless in case of emergencies. An excused absence includes vacation, sickness, & personal emergencies and is per board discretion by majority.
  - ii. An unexcused absence is when a board member does not attend a meeting without notifying the YAR President and/or YAR coordinator of absence prior. This is per board discretion based on circumstances of absent board member.

## **VII. GRANT GUIDELINES:**

- A. Projects must be youth-designed, youth-led, and presented by youth. Projects must be completed with a summary report and a project book.
- B. Youth are defined as high school seniors or younger.
- C. Failure to return summary report and/or project book may disqualify group from any future funding.
- D. Usage of funds can be restricted by the YAR Board on a case-by-case basis.
- E. Unused funds must be returned by the service group to the YAR Board upon completion of their service project.
- F. Recipients of grants may not use grant money to discriminate on any basis.
- G. Projects must serve the Kenosha County community.





- H. YAR board members are not permitted to submit a YAR grant proposal; however, they may be “associated” with a group who submits an application. The YAR Board member will recuse themselves from the discussion/voting on any proposal where they are a member of the group submitting the proposal.
- I. Projects are required to indicate that the project was funded by Youth As Resources.

### **VIII. LEONARD AND PATRICIA JOHNSON AWARD**

- A. Service groups that receive YAR grants and complete their service project during each YAR year are eligible for the Leonard and Patricia Johnson Award.
- B. If a group completes their project in a year different from the year they received grant funds, they are eligible for the award during the year of project completion.
- C. Criteria for the award include: Leadership, Citizenship, and Community Service.
- D. Whenever possible, a member or members of the Leonard & Patricia Johnson Family will provide input into the selection of the award recipient.
- E. Board members will vote on groups or individuals who meet the above criteria using a nominal group technique (voting with dots) and take into consideration the Johnson Family recommendations for the award recipient.

### **IX. AMENDMENTS**

- A. Any amendments of the bylaws must be approved by a two-thirds vote of the YAR Board.

## Conflict of Interest Policy

The standard of behavior at United Way of Kenosha County is that all staff, volunteers, and board members scrupulously avoid conflicts of interest between the interests of the United Way of Kenosha County on one hand, and personal, professional, and business interests on the other. This includes avoiding potential and actual conflicts of interest, as well as perceptions of conflicts of interest.

I understand that the purposes of this policy are to protect the integrity of United Way of Kenosha County's decision-making process, to enable our constituencies to have confidence in our integrity, and to protect the integrity and reputations of volunteers, staff and board members. Upon or before election, hiring or appointment, I will make a full, written disclosure of interests, relationships, and holdings that could potentially result in a conflict of interest. This written disclosure will be kept on file and I will update it as appropriate. In the course of meetings or activities, I will disclose any interests in a transaction or decision where I (including my business or other nonprofit affiliations), my family and/or my significant other, employer, or close associates will receive a benefit or gain. After disclosure, I understand that I will be asked to leave the room for the discussion and will not be permitted to vote on the question.

I understand that this policy is meant to supplement good judgment, and I will respect its spirit as well as its wording.

## **Endowment Fund**

The cornerstone of the Youth As Resources program is the idea that youth can make meaningful, not just symbolic, contributions to their communities, and that these contributions provide important opportunities for youth to grow professionally and personally.

In memory of her husband Leonard Johnson, Patricia Johnson donated the initial funds to start the Endowment Fund in 2008 with the Kenosha Community Foundation. The fund is designed to ensure the long-range sustainability of the Kenosha County Youth As Resources program, as only the earnings of the fund will be used to support local youth-led service projects.

The Kenosha County Youth As Resources (YAR) Endowment Committee provides oversight of the Youth As Resources (YAR) Endowment Fund in collaboration with the Kenosha Community Foundation.

The Endowment Committee will assist the Kenosha County Youth As Resources (YAR) Board in creating an awareness of the Endowment Fund and the benefits it offers to the Kenosha County Youth As Resources (YAR) program. The Committee will direct the solicitation of funds through donations of cash or property from various sources including bequests and memorials.

Earnings from gifts and bequests to the Fund may be used for projects or programs recommended by the Endowment Committee, and then approved by the Director of Extension Kenosha County.

The Youth As Resources Endowment Committee consists of no fewer than 5 members and no more than 9 members.

The fiscal year of this Fund shall be January 1 – December 31.

Anyone can contribute, and any size gift is accepted. Cash gifts, memorials, bequests, and property, including stock are appreciated. All contributions and gifts are tax deductible as provided in Section 501(c)(3) of the Internal Revenue Service Code. ## Leonard and Patricia Johnson Award Selection Criteria

### Purpose:

The purpose of Leonard and Patricia Johnson Award is to recognize an outstanding Youth As Resources project annually.

### Criteria:

- Leadership
- Citizenship
- Community Service

Groups and/or individuals who receive a Youth As Resources grant and complete their service project during each Youth As Resources year are eligible for the Leonard & Patricia Johnson Award.

If a group or individual completes their project in a year different from the year they received grant funds, they are eligible for the award during the year of the project completion.

Whenever possible, a member or members of the Leonard & Patricia Johnson Family will provide input into the selection of the award recipient.

Youth As Resources Board members will vote on groups and/or individuals who meet the above criteria using a nominal group technique (voting with dots) and take into consideration the Johnson Family recommendations for the award recipient.

### Leonard and Patricia Johnson Award Plaque:

Award recipients will have their name engraved on the award plaque and will be presented a certificate at a Youth As Resources Board meeting.
